GOLDTREE SIERRA LEONE LTD of Sierra Leone has commissioned SCS Global Services to conduct an RSPO Certification Assessment of its palm oil mill and supply basin located near Daru, Eastern Province, SIERRA LEONE. The assessment will be conducted of 1 Palm Oil Mill, and 1 Oil Palm Plantations.

SCS Global Services plans to conduct the Certification assessment of the **GOLDTREE SIERRA LEONE LTD** mill from **16-18 of September 2020**. The assessment will be conducted against the Roundtable on Sustainable Palm Oil requirements, including the Principles & Criteria (RSPO P&C 2018), with updated Supply Chain requirements for Mills.
